

Did You Know November... Is National Diabetes Month

Diabetes impacts more than 30 million Americans, National Diabetes Month focuses on providing education and encouragement to make healthy changes in hopes of reducing the risk of type 2 diabetes.

Banana Pudding Lovers Month

Here is some fun banana pudding history. More than 100 years ago, after the Civil War ended, steam ships were improved and bananas became a regular import from the Caribbean and Central America, banana pudding was born. With its first recipe reportedly published in an 1888 issue of Good Housekeeping, the recipe called for a pint of chilled custard, sponge cake and bananas.

By 1890 more recipes came along with substitutions such as lady fingers rather than sponge cake, tapioca instead of custard and making a gelatin mold rather than layering. But the longest lasting substitution replacing the sponge cake, Vanilla Wafers, appeared in the 1920s. As a result in the 1940s, Nabisco began printing their own recipe on the Vanilla Wafers boxes.

Perhaps this holiday season you can find an occasion to make some delicious banana pudding!

Leon County Ordianance Section 4-43 Removal of Animal Waste subsection (a) says "It shall be unlawful for any owner of an animal to fail to remove any feces deposited by his or her animal on public walks, recreation areas, public streets, or private property other than the premises of the owner of the animal." This is supported by Section 4-29 Enforcement generally; penalties. 1st Violation - \$50.00, 2nd Violation - \$100.00, 3rd Violation and every violation thereafter - \$250.00. That's some expensive poo!
